Directions:

From Puyallup

1. Drive north on Meridian to Hwy 512. Enter 512 eastbound (down the hill) drive 3 miles to Hwy 167 northbound.
2. Take 167 northbound for 1 mile then take Hwy 410 eastbound marked Yakima/Sumner next right.
3. Drive 2.6 miles and take the 3rd Sumner exit marked 166th Ave E.
4. Turn left and drive under the overpass for .5 miles to 60th Street E.
5. Turn left onto 60th Street E. and drive .3 miles. Agility Center and Hospital are on the left side of the road.
